We refer to the news article entitled “Pure Foods building new two-hectare Laguna plant” posted in Manila Standard.net on February 18, 2018. The article reported in part that:

“San Miguel Pure Foods Company Inc., the food manufacturing unit of conglomerate San Miguel Corp., said it plans to open a new manufacturing facility for ready-to-eat products in Santa Rosa, Laguna by the first quarter of 2019.

SMPFC said in a statement the facility, spanning 20,000 square meters, would address consumer demand for convenience and capture a larger chunk of the fast-growing segment.

Once operational, it will produce fully cooked viands and heat-and-serve meals to serve growing consumer demand for convenient, nutritious meals differentiated by home-cooked taste, rich quality, and the highest levels of food safety, it said.

The plant and commissary will also cater to foodservice clients’ operational needs for high-quality, healthy and easy-to-prepare meals. It will also yield products for export in the ready-to-eat format, SMPFC said.
